From all of us at NVFAC, we wish all of you a prosperous, happy, blessed and free 2020.


Development Division

s we approach the end of 2019, I look back on what we achieved in the Development Division and realize that one person can only do so much. Having a full-time job is limiting and I welcome ANY help whatsoever to increase donations in 2020. Without money and volunteers an ALL volunteer non-profit can't do more.

In 2019, we added the NVFAC Foundation to both the Amazon Smiles and the Smith's Inspiring Donations programs. Both programs donate money to 501c3 non-profit charities. All you have to do is register and shop and Amazon and Smith's will donate THEIR money; you are not donating money you are just shopping as usual.

Unfortunately for us, the IRS stated that we did not submit our form 990 for three years and revoked our exempt status. This removed us from the list on GuideStar, which Amazon uses to determine eligibility. After chasing the IRS and providing evidence that we did in fact submit



the forms, they said THEY made the mistake and it will take up to six weeks to reverse it. So we have not been able to get new Amazon shoppers to choose the foundation and have only 167 customers currently supporting us. We have lost the last 3+ months of increasing that number. We are hoping that we can motivate more to sign up once we get back on the list. In the meantime Amazon is still donating to us for those that are currently supporting us. Look out for announcements to join the program once we are reinstated.

Southern Division

The primary intent for the South Division is to increase the membership of NVFAC. To attain that, the focus has been, as it turns out, utilizing attendance at gun shows to reach non-member population. Typically, NVFAC borrowed table space from the Republican Party recruitment team.

Since the tragic 2017 murders at the Mandalay Bay and the corresponding increase of anti 2A politics in Clark County, we saw a slight uptick in membership at the gun shows we attended, the biggest increase at the shows held at the Pavilion. Those gains were, however, shortlived, as membership interest declined to the seemingly norm of a small handful per show.

Other strategies were discussed to get our message out to the general public, including town

hall meetings and reloading classes. The idea is to engage the public on a common platform that would translate into a better understanding of the pressure put on the 2A and creating a focused political strength without compromise of other traditional political beliefs. Two limiting factors became evident: a) time; and b) money.

I am convinced there is opportunity to reach the public, even in areas that would not be considered gun supporters; however, to do that requires a great deal of time to devise and implement an effective strategy and then the money to execute that strategy on a tactical basis.

Until we can secure our own Bloomberg or Soros, we'll continue with gun shows and continue with plans to introduce a NVFAC sponsored reloading class. Details will be provided as they become available.

continues to shatter national records! Since the first class was held in April 2019, the women's program has trained 3,094 women in firearms safety, safe storage and basic pistol craft. The Annie Oakley team, consisting Team Coordinator of their Morgan, Jeannette NRA certified Instructors, Range Safety Officers and program coaches have provided 267 range sessions and 144 safety classes. Besides introducing 3,094 firearms women to safety, they have supervised 7,378 women shooters, trained 111

team members and provided advanced training to 375 women. We are looking forward to continued successes in 2020. The program is offered every Tuesday night from 630 pm to 9 pm at the Clark County Shooting Complex.

New Year's Gifts Courtesy of Nevada's Democrats

law-abiding gun owners some lumps of coal for their Christmas stockings in the form of several gun control laws that take effect with the New Year.

Piece of Coal No. 1 is the so-called Universal Background Check, which requires that most private firearms transfers be processed by a federal firearms dealer (FFL), who is required to do a NICS check on the receiver of the firearms. Exceptions are antique firearms, transfers between family members, transfers from a trust, or temporary transfers between lawful gun owners for hunting or recreational shooting, or where the firearms will be used in the presence

of the owner. According to the text of the statute, Nevada's Concealed Handgun Permit(CFL) holders are exempt from the background check requirement, with thev are firearm as purchases from an FFL, but in a classic example of bureaucratic arrogance and over-reach, the Nevada Department of Public

Safety decided to add to the statute that the CFL exemption would not apply. Asked where the authority for that addition came, since it is definitely NOT in the statute as written and passed by the legislature, the law expanders, with a straight face, replied that they got it from the legislative committee discussion of SB 143. As of New Year's Day, if you want to sell a personal pistol, rifle, or shotgun to another private citizen, you and the buyer are supposed to hunt up an FFL and have him or her process the sale, which means logging it into their books, doing the NICS check, and either allowing or denying the sale depending on what the NICS result is. If the buyer fails the NICS check, the seller must undergo a NICS check before he gets his gun back. If the seller fails



revada's Democrat's gave Silver State's the NICs check, he doesn't get his gun back. While the State of Nevada does not charge a fee for the NICS check on a private sale, the FFL may charge a "reasonable fee". Let's see what "reasonable" turns out to be.

> As some of you may already know, I used to be a cop. I cannot see how the police are going to enforce this universal background check law. A study sponsored by the U.S. Department of Justice in 2003 determined that it would require a national universal firearms registry to effectively enforce a universal firearms background check. Except in cases of newlymanufactured firearms sold after 1 January 2020, where the investigative burden would

be somewhat easier (call up the ATF and see which FFL sold the gun, then go check his records), will be an investigative it nightmare to try to verify gun transfers in the private market. Given that our Fifth Amendment rights against self-incrimination mean we cannot be compelled to help the cops prosecute us,

if I were still enforcing the law, I would have a hard time gathering sufficient evidence to prosecute someone for failing to comply with the background check law. That is the biggest reason I believe this entire Universal Background Check is a charade, so the gun-grabbers can come back in a few years and demand a national firearms registry to allow them to enforce the background check system.

Piece of Coal No. 2 is the Red Flag Law, also known as Extreme Rick Protective Orders, which allows complaints to a judge from family members and law enforcement officers to be heard in what are called Ex Parte hearings. "Ex Parte" is a legal term meaning only one side of a dispute is present at the judicial proceeding. How might that work in practice, you ask? Good

question!

Let's suppose that Jane Smith is dating Tom Jones. Jane, angry at Tom because he did something she didn't like, goes to a judge and says she's afraid of Tom, and tells the judge that Tom has a lot of guns. She asks the court for an order seizing Tom's guns. Tom is not required to be notified of the hearing, is not required to be present at the hearing, has no opportunity to challenge the proceedings, and is not required to be notified of any resulting court orders stripping him of his Second Amendments rights

before armed police come to his house with a warrant to seize his guns. Red Flag proponents said when objections were raised to the lack of notice to the victims of the process that such notice might put the people requesting the gun seizure "at risk," whatever that means.

Note, too, that Tom has not been charged, much less convicted, of a felony, or crime of domestic violence, which are the legal requirements for stripping someone of their gun rights. With this law, Tom, or anyone so accused of "being at risk for

dangerous behavior," can lose his gun rights without having broken any law. In a constitutional republic dedicated to the protection of individual rights and the rule of law and not of men, that ain't right!

If ever there was a classic violation of due process, this Red Flag law is it! For those of you who haven't read up on your legal history lately, the idea of due process is an ancient and sacred one in the Anglo-American legal tradition. It goes all the way back to 1215 in the British Isles, when the English barons compelled King John to sign what came to be known as Magna Carta, the Great Charter, and agree that he would no longer try to do whatever he wanted to whomever he pleased. Magna Carta is the direct intellectual ancestor of our Declaration of Independence, Constitution, and Bill of Rights. After Magna Carta, if English kings wanted to arrest someone, or hold their property and goods forfeit, or put their lives in legal jeopardy, they had to follow an established legal process, meaning go before a magistrate get a warrant, hold public trials, and allow the accused to present evidence in his behalf.

Fast forward to 2020, and due process and the rule of law is the very bedrock of our system of ordered liberty and protection for individual rights. That is true even in recently-blue Nevada, where it is contrary to both federal and state constitutions and statutes to seize guns without a court process which includes an impartial judge, right to legal counsel, notice of proceedings against the accused, the right to confront accusers, the right to contest the charges, and evidence of a crime – or at least it was until 1 January 2020. Even the Nevada Chapter of the

American Civil Liberties Union, historically no friend to gun rights despite having a stated purpose of protecting the Bill of Rights, had trouble with the lack of due process in the Red Flag bill when it was first introduced during the last legislative session, but they subsequently grew strangely quiet and did not oppose the Red Flag law when it came to a vote. Get ready for a ride down the slippery slope when the legislature convenes for the 2021 session, unless the Democrats lose one or both chambers in the November general election.

Another Piece of Coal, though not from Nevada Democrats, is the entry of Michael Bloomberg into the 2020 Democratic presidential primary race. The former Mayor of New York City, and a noted gun control advocate, had a Christmas list of pet gun control measures he promised to impose on America if he wins the White House. Among his wish list is the obligatory universal background checks, 48-hour waiting periods for all gun purchases, universal firearms registration, firearms owner identification cards (required before any gun purchase in addition to background checks), another assault weapon ban, and raising the age for owning firearms to 21. Pray that this man does not win the White House!

As Ronald Regan famously, and accurately said, "Freedom is but one generation away from extinction" in America. It must be renewed by each generation to ensure its survival into the future. That means us. We must defend and renew it, or lose it.
