



n Wednesday February 5th. The Elko County Commissioners held a meeting to authorize Elko County to intervene, file an amicus brief or take other action in a lawsuit which challenges the constitutionality of AB 291, Nevada's new Red Flag gun law, and specifically alleges that the law violates the Second Amendment of the United States Constitution and Section 11 of the Nevada Constitution

Sheriff Aitor Narvaiza spoke at this meeting stating that he took an oath to protect the constitution of the USA and the state of Nevada. He told lawmakers to keep their hands off our guns. He also asked the County to help fight in this law suit. Also in attendance was Eureka County Sheriff Jessie Watts who also spoke at

the meeting stating that he stands "shoulder to shoulder" with Sheriff Narvaiza. He stated they were the first to sign on to the intervention and an amicus brief.

State Assemblyman John Ellison also spoke in favor of taking a stand. He also passed along some very interesting information as to who we are up against. This is really a complicated issue as far as what can happen by doing an amicus brief and also intervening.

Bottom line on the meeting: Demar Dahl Chairman, talked a bit about Elko County and other fights the county has participated in. He then called for a vote to intervene and file an amicus brief. It was unanimous and Elko County will get into this suit. There were well over 150 people in attendance packing the house.

s we enjoy the interim between legislative sessions, the NVFAC is preparing to help Leducate more new firearms owners and possibly, the future generation of the shooting sports. NVFAC has partnered with Carson Guns & Training, NDOW and the City of Carson to organize a monthly shooting event with the purpose of teaching the public gun safety, gun handling and the principals of marksmanship. As responsible gun owners, we must remember to be vigilant when using firearms. Last year, Washoe county experienced 10 wildland fires caused by irresponsible target shooters on BLM and forest service land. In response to this, the forest service is doubling down on their campaign to educate target shooters on the actual dangers of shooting on public land. Please remember to take a shovel, fire extinguisher and water with you when shooting on public lands. Do not use steel core or steel jacketed ammunition and have a safe backstop to shoot into.





"Now Is the Time . . . "

o paraphrase Patrick Henry, now is the time for all gun owners to come to the defense of that most basic of rights, the right to arms.

That right has taken a beating lately, but the worst is yet to come if Silver State gun owners and like-minded people do not come out and vote in sufficient numbers to capture at least one chamber of the state legislature in the upcoming November general election. Currently, Democrats hold a 13-8 majority in the state senate, and a 28-13 majority in the state Assembly, as well as holding the Governor's mansion. While Democrats are not automatically anti-Second Amendment, as I like to say, that's the way to bet. The current crop of Nevada Democratic state legislators, as I reported in the last Firing Line, gave us so-called Universal Background Checks; and Extreme Risk Protection Order, otherwise known as gun seizures without due process. Still on their legislative wish list is a semi-auto ban (they call it an assault weapon ban); a ban on magazines carrying more than ten rounds; a waiting period for all gun purchases; an increase in the legal age to own and purchase firearms to 21 years; and a repeal of the state pre-emption law, which will allow counties and local governments to pass gun regulations, thus returning Nevada to the crazy-quilt of gun laws that existed prior to NVFAC's successful passage of the 2015 preemption revisions.

The national situation looks not much better. Every Democratic candidate for President of the United States has come out in favor of what they call "common sense" gun regulations, including all of the above-mentioned items and more. Chief among them is former New York City Mayor Michael Bloomberg, who would expand the above list to include firearms owner identification cards (required before any gun purchase in addition to background checks).

The one bright spot on the gun-rights horizon is President Donald J. Trump. He may be the strongest supporter of the Second Amendment ever to occupy the White House. His record-

breaking appointment of conservative, originalist, strict-constructionist judges to the federal bench may prove to be his best legacy, and hopefully those jurists will prove themselves to be strong supporters of gun rights — not by any ideology they may hold dear, but by simply enforcing the Constitution as it is written.

That should make the re-election of President Trump a priority for Second Amendment supporters. There is much to not like about his demeanor, and his failure to have a throttle for his mouth, or his seeming lack of impulse control, but his solid support for the Second Amendment and the other results he is getting are hard to argue with.

Every election is a choice between at least two alternatives. A rule that I use when making personnel retention decisions comes to mind: if the good outweighs the bad, then you keep 'em, and vice versa. In my opinion, for gun owners at least, the good that will come with retaining the President in office outweighs the irritation of his manner, and far outweighs the bad that will come in the train of a Democratic administration, especially so if the Democrats take control of the federal Senate as well as the Presidency.

That's why I say that this is the time to come to the defense of the Second Amendment, both in the Silver State, and our republic. You can do that by registering to vote, then encourage your friends and family to register to vote, then get them to encourage their friends and family and acquaintances to register to vote. Come election day, actually get out and vote for your gun rights, and take family, friends, neighbors, and co-workers to the polls with you so they can vote for their gun rights.

If you can afford it, donate to the party and candidates that you think will best defend our gun rights, and donate to the NVFAC-PAC, which helps us defend your gun rights. No NVFAC board members, or PAC members, receive a penny in compensation. Those are entirely grass-roots organizations, so every penny you
