# **Range And Retail Division**

### **Clark County Range Development Committee**

In Southern Nevada, we are lucky to have the Clark County Shooting Complex (CCSC). By size, 2900 acres, it is the largest public shooting facility in the United States. The issue is that it is only 1/3 complete.

The importance of the CCSC in the protection of Nevada's 2nd Amendment rights is not immediately obvious to the casual observer. For many shooters in Southern Nevada, this public facility offers 100 and 200-yard rifle ranges, trap and skeet shooting, pistol shooting, RV park, and an archery facility that is family friendly and does not require an annual membership. CCSC also has many user groups that use dedicated educational ranges for many different classes and events. Having a public place to shoot, a place without restricted membership, and a place for all types of firearms, grows the 2A community. For this reason, good public ranges are a must for our cause.

One of NVFAC's priorities, in addition to the protection of our rights, is the completion of the Shooting Complex. The next stage is 30 tactical bays that were included in the original design of the park, but were left out for the opening in 2010. The master plan called for 30 bays, 3 classrooms, restrooms and other supporting features. 27 of the bays are 50 feet wide by 50 yards long. 3 of the bays are 50 feet wide by 100 yards long. Each bay is surrounded by

To have these bays available would drastically increase Southern Nevada's ability to have simultaneous shooting events! Additionally, for high profile conferences like the SHOT show, it would make Southern Nevada even more desirable for the firearm industry.

We need your help to make this priority a reality by getting involved in the political process of developing the tactical bays at CCSC. s we start to get back to normal from the COVID19 issues, we are looking to get back to work on the projects we had to put on hold. I've been meeting with local groups in Washoe county, (mostly though Zoom meetings) to continue to educate our citizens on the work that NVFAC does, the new gun laws we are now living under and what we expect to see come down the pipeline next legislative session. I've also been interacting with new gun owners every week who have until now, never thought they would be a gun owner. I believe it's of paramount importance for those of us who know of a new gun owner to be a positive influence on them and make sure they are educated in safe and responsible gun handling.

We've built some new relationships, but we still need help from people who can organize events, stay motivated and get things done. Some things have turned around for us. The Carson City gun range is now open to the public 6 days a week and is under the entire control of the City of Carson. The Washoe County shooting facility has been open and local instructors are teaching CCW courses again. Washoe County and the BLM are still assessing locations to build designated shooting areas and I will be working closely with them to implement a solid plan to reduce the dangers of wildfires caused by target shooting. #### LVMPD and BLM Officials Combatting a Spike in Illegal Activity on Public Lands

Law enforcement is dealing with a spike in illegal activity on Bureau of Land Management (BLM) public lands, causing the Las Vegas Metropolitan Police Department to step up patrol in those areas

Visitor volumes have surged to four times the normal level amid the COVID-19 "Stay at Home" order. BLM authorities are reporting increased illegal activity of off-highway vehicles, target shooting, camping and illegal dumping—all which carry hefty fines. If caught, the penalty for these activities can result in up to six months in jail or a \$1,000 fine. Target shooting is legal outside of the valley when it is a half-mile from a state highway or 500 feet from a road. But, it is illegal to shoot near a residential area.

Authorities have also reported seeing a lot of the activities in or around the Red Rock area, prompting the LVMPD to close Calico Basin Road, which accesses several trails in the Red Rock area.

Restrictions on shooting and off-road use are in effect for all areas within the valley. These restrictions have been put in place to protect the residents within the Las Vegas Valley who are venturing into public lands that border populated areas. These closures are to maintain public safety and air quality standards for the residents of the Las Vegas Valley.

BLM recreation lands will remain open unless state or local authorities have ordered or recommended closure of public lands e.g., "Stay at Home" orders.

# **Legislative Affairs Division**

### **Rating the Candidates**

Rating candidates for NVFAC and its PAC since the 2012 election has been a fairly straightforward process.

First, we develop a survey each cycle based on issues important to our membership, limited to Second Amendment issues. Then we send the survey to candidates, usually by email but sometimes by fax, and a very few by the U.S. Postal Service. Those candidates who do not reply to our survey gat an "Ftr" rating for Failure to Return Survey. Those candidates returning the surveys are scored and rated on how many of the issues in the survey they support. For example, in the current cycle, support for all our issues gets an "A". Miss even one and that's a "B"; missing two is a "C" and so forth.

We take candidates at their word in their survey responses, and try to keep track over the election cycles to see whether candidates are true to that word. Legislative sessions usually give us what we need to separate the doers from the talkers. Also, paying attention to campaigns over the years, to see what repeat candidates have supported, or in some cases, not supported in times past, is instructive.

For legislators who have worked well with us in legislative sessions by, for example, sponsoring our bills, working to marshal legislative support

for our bills, or taking unpopular votes in support of our bills, or helping the Second Amendment in other ways, we have an "A+" rating. Candidates who are NVFAC members get an asterisk by their rating.

Endorsements are another matter. We look more closely at candidates for evidence of accomplishments and a history of demonstrated support of the Second Amendment, especially in Nevada. We often get calls from candidates touting their solid and long-standing support of gun rights. Almost all will tell us they have a concealed firearm permit, sometimes for years, or even decades. That's nice, we say, but what have you actually DONE to support the Second Amendment., we ask? Silence. Sometimes a candidate's reports being a Life NRA member Very few tell us they are NVFAC members. As an aside, apparently, it never occurs to many candidates to join the organization they are asking for an endorsement. We don't want our endorsements to be like M&M's at Hallowe'en, handed out to anyone who knocks on our door. Consequently, NVFAC-PAC has endorsed very few candidates over the years.

There is also a difference between a rating and an endorsement, and the two are often both confused and conflated. We had to reach out to candidates this cycle to remind them that they were rated, not endorsed, after they had claimed in print or broadcast advertising that they were endorsed by NVFAC. We also had to remind them the rating came from NVFAC-PAC, not from NVFAC. Both organizations, while related, are 501C)3 corporations. The NVFAC can rate candidates as part of its educational mission, but it cannot engage in promoting individual candidates, which means no candidate endorsements. Our PAC is incorporated as a State of Nevada 501(C)3 corporation, which means we can rate both state and federal candidates for office, but can only endorse state and local-level candidates, not federal candidates. We would need a separate PAC chartered under different rules to endorse candidates in federal elections.

(Candidates - Continued from Page 7) This cycle, we tried something we haven't done often over the years: surveyed candidates in the Primary election. You can see the results at www.nvfacpac.org.

We also tried making our surveys and their completion and compilation of results more digital, meaning candidates can go to the www. nfvacpac.org website and complete the survey. The website computes from the completed survey the number of issues supported, and sends the results on to us, at which time we send the candidate his/her rating. If it's an "A" or "A+', we also send a rating logo they can use in their campaign advertising.

While NVFAC and NVFAC-PAC are not partisan, what we usually get is surveys from Republicans, Independents, Libertarians, or the Independent American Party. We typically get very few surveys from Democrats, and I suspect the few we do get are from candidates who use a low rating from us as evidence to show their constitutions that they are NOT gun-

friendly. We have even, over the years, had a few Democratic candidates both indignantly refuse to complete our survey, and throw in insulting language about our organization and its ideals.

After the Primary election results are in, we will send survey requests to those candidates who survived their primaries, and show "Ftr" for those who choose not to participate in our candidate issues survey. We think our members and interested parties are entitled to know that.

The 2020 election cycle is more intense, loaded with more surprises and twists and turns, and more and different major issues than any I can remember or have read about, and I was a history major in college! And its only June; the official campaign season hasn't started yet! If nothing else, it will be interesting and exciting to watch!
