The quote refers to the importance of funding when it comes to aviation and space travel. The full quote is as follows: "You boys know what makes this bird [aircraft] go up? FUNDING makes this bird go up." He's right. "No bucks, No Buck Rogers."

For the benefit of our younger readers, Buck Rogers is a fictional science fiction character that was first introduced in August 1928 and one of the first fictional space explorers. Buck

(Development - Continued from Page 3) Nevada n who believes in the Second Amendment works to protect the Second Amendment in Nevada, then little-by-little Nevada will begin to resemble California, where voters recently passed a law that requires background checks for the purchase of firearm ammunition.

Consequently, I am asking every member of the Nevada Firearms Coalition to help us with our 2017 fundraising efforts so that we can continue to protect the Second Amendment in Nevada.

The following is a partial list of our planned fundraising activities:

1. To create an Inaugural and Annual Patriot Day Dinner on around April 11th.
2. Create a Shooters' Discount Card that will enable the cardholder to receive discounts at shooting ranges, firearms stores, hunting and outdoor stores, such as New Frontier Armory, Green Valley Range, etc.
3. Create a monthly breakfast/brunch/lunch/dinner with a Second Amendment eating establishment in which NVFAC members can socialize and the help with the NVFAC

fundraising efforts.

4. Recreate an NVFAC event which combines 9 holes of golf along with a shooting event (Trap, skeet, etc.)
5. Create an inaugural and annual fundraising event in which NVFAC members sell the opportunity to have someone gently place a pie in their face or dunk them in a tank of water during the summer months.
6. Create NVFAC Sweepstakes, Raffles and donations.

We all know that we suffered a serious setback with Question One's universal background checks passing the voters just one month ago. The vote was remarkably close statewide, with only Clark County supporting that law. However, the gun grabbers are already upping their game with more misinformation about lawful firearms ownership. Don't forget that the change of leadership in our state legislature make us all

the more vulnerable to bad legislation if that misinformation goes unaddressed.

Southern Division Report

This election cycle was a bittersweet one. With Donald Trump's presidential victory and Republicans maintaining control of the House and Senate, things are looking up for the Second Amendment on a Federal level.

Nevada did not fare as well. We lost Bloomberg's Question 1 by less than 10,000 votes statewide. Due to the amazing work of dedicated volunteers, things could have been a lot worse. Additionally, the Nevada State House and Senate went to a gun-controlling Democratic majority, and this is going to cause problems for gun-owning Nevadans.

Sheriff Lombardo recently stated that he is in favor of limiting law abiding Nevadans magazine capacities to 10 rounds. We MUST NOT let this happen. The biggest step you can take is to join

NVFAC and encourage others to do the same. We will be fighting this tooth and nail, and rest assured that this is only the beginning of the assault on our gun rights during the 2017 state legislative session.

On a more positive note, NVFAC is putting together an all woman's shooting program called the "Annie Oakley Sure Shots" (AOSS). This totally free program will include an hour-long training class, free use of 22 caliber firearms, free range time and 250 rounds of 22 LR ammo. The AOSS program will be open to women 14 years old and up and is free and open to the public. This program will be held every Tuesday night at the Clark County Shooting Complex. We are in need of women instructors, coaches and range safety officers who would be willing to donate their time helping other woman learn to shoot. PURPOSE: To be responsible for monitoring conservation activities and to provide information to members regarding conservation activities and concerns.

ACTIVITY: Build a team of conservation activists who want further conservation efforts with a clear focus on hunting and public hunting access.

TASK: Add to the existing list of loyal NVFAC volunteers who occasionally help with NDOW and Commission events. This group directs the overall conservation viability/stats in Nevada.

TASK: Continue relentless pro conservation pro firearms representation at NDOW/ Commission meetings and our CAB meetings. Foster and recruit individuals who wish to be active in achieving NVFAC conservation objectives. Continue to have pre team meetings and assign specific responsibilities in order to broaden

our impact with the commissioners.

ACTIVITY: Help limit federal agencies like BLM (Bureau of Land Management) and US Forest Service from the massive and continued [elimination/restricted access of public lands](#) available to "multiple-use" enthusiasts.

TASK: Host a major clean up at the Corn Creek Area north of town off of I-95.

ACTIVITY: To investigate hosting and sponsorship of programs that provide an introduction to hunting/conservation, such as NRA YHEC or "Becoming an Outdoor Woman", or to develop a NVFAC FOUNDATION Signature program for hunting/conservation recruitment and training.

NVFAC-PAC LEGISLATIVE PRIORITIES For 2017 State Legislature

- ☞ NVFAC-PAC will support any firearms legislation where analysis shows an enhancement of personal liberty and significant public benefits.
- ☞ NVFAC-PAC will oppose any firearms legislation where analysis shows that the public safety benefits are an intrusion into personal liberty.
- ☞ Support gun rights legislative gains in 2013 and 2015 sessions.
- ☞ Support Sales Tax exemption for non-retail sales by gun dealers.
- ☞ Because Ballot Initiative One passed, eliminate NV DPS POC and go straight to NICS for all background checks.
- ☞ Develop comprehensive firearms definitions.
- ☞ Promote early CCW renewal and correction of 60-day CCW requirement for new residents to conform to 120-day current wait.
- ☞ Take away authority of Nevada Wildlife Commission to regulate firearms and return authority to Legislature.
- ☞ Request Attorney General to sue for Second Amendment violations.
- ☞ Promote Gun Safe Sales tax waiver, Permit-less Carry and Campus Carry.
- ☞ Randi Thompson has been hired as the full-time lobbyist for our PAC.
- ☞ Amplify Relations has been contracted as our PAC management company.
