

pril 1st, 2017 was April "Firearms Day" for Nevada Firearms Coalition members. Coalition members enjoyed "Free Range Time" from 8 am till noon at the Clark County Shooting Complex (CCSC) Education Center's 50-yard range. That afternoon Coalition members took part in a National Rifle Association (NRA) Basics of Pistol Shooting (BOPS) Phase 2 course.

While the firearms were banging away up at CCSC other Coalition members were engaged in the classroom portion of the NRA Personal Protection In the Home (PPITH) course at The Safe Keeper on West Charleston Blvd. The PPITH participants completed the range portion of the course on Sunday afternoon at CCSC.

The no and low cost firearm activities described above could not have taken place without the NRA Instructors, Range Safety Officers and local business owners who volunteered their time and/or resources to make the events happen. Thanks to Alexandra, Dena, Joan, Wendy, Jake, Lyon, Lana and Don for your support.

With the reintroduction of Instructor Led Training for the NRA Basics of Pistol Shooting course, along with modifications to the Blended Learning approach, the Coalition's course offers have changed to incorporate the changes. Henceforth, the Coalition training team will focus on conducting the Instructor Led Training for the NRA Basics of Pistol Shooting course. The Blended Learning approach is available, upon request, for those who prefer accomplishing the classroom portion of the course online.

The next "Free Range Time" for Coalition members is scheduled for the morning of Sunday, May 7th, 8 am till noon at the CCSC Education Center's 50-yard range. Coalition members are encouraged to come up and participate under the watchful eyes of NRA Range Safety Officers.

On May 6th and 7th, the NRA PPITH course is again offered with the classroom portion on Saturday at the Safe Keeper and the range portion accomplished Sunday afternoon at the CCSC range. The PPITH course strives to educate participants on ways to make you and your home safer along with how to incorporate use a firearm for home defense. Space is limited, so sign up early if you wish to participate. Completion of the NRA Basics of Pistol Shooting course is a prerequisite for PPITH.

The classroom portion of the NRA Personal Protection Outside the Home (PPOTH) course will take place at The Safe Keeper on Saturday, 27 May, with the range portion being accomplished on Sunday, May 28th at the CCSC range. The PPOTH course is a 14-hour course where you will be taught conflict avoidance, how to present your handgun from concealed carry to engage a threat, legal issues and other related lessons. Completion of the NRA PPITH course is a prerequisite for the PPOTH course.

It is only through the support of NRA Instructors, Range Safety Officers and local business owners that such no and low cost events and courses may be offered to Coalition members. # "Fighting the Good Fight"

To say that this 79th (2017) Session of our Nevada legislature has been L trying for conservation would be an understatement. The attack on our ability to manage wildlife conservation was unrelenting and filled with unconscious incompetent bills making zero logical sense. One of the scariest bills I've seen in a long time were AB187 and AB 373. The good thing is that sportsmen and firearms enthusiasts dominated the legislative work session event, with only a handful of members of the public speaking out in support. This was a prideful day for all conservationists in our state! We ultimately won this battle and many others with many anti-gun, anti-conservation bills left to die in committee.

We had dozens of professional wildlife folks,

including past NDOW directors and current commissioners, as well as sportsmen and lots of firearm owners who spoke passionately about protecting wildlife and our rights. The only thing that would have made this better was if the ELKO feed would have worked as there were dozens of sportsmen wanting to speak but who could not! Here is a copy of my testimony, I've also included the live-link of the session. I assure you it is educational and stands as a stark reminder of just how important our vote is.

## Chairman, and Judiciary Committee Members:

My name is Julius Fortuna and I represent the Nevada Firearms Coalition as the Conservation Director. We represent thousands of your constituents who are quite frankly appalled by AB 187 and now AB 373. Our social media went off the chart with this, so I'm here taking a morning off of my (Continued on Page 9 - Conservation)

(Conservation - Continued from Page 8) work to voice our opposition to which. I will keep it to 3 key objections and 2-3 minutes.

1. Let me share with you a powerful statement by Director Tony Wasley NDOW... and I quote "892 different species regularly occurring in Nevada the vast majority of that financial management comes from less the 10 "consumptive" species. Like many things in the public right now there is a lot of FAKE news on who exactly pays for wildlife, which is germane to my argument. Bottom line is if you ask the NDOW Director Wasley he will tell you his money comes from 3 buckets... 86% 2/3rds come from sportsmen "wildlife fees" with "matching grants, from hunting/fishing activities.

The other budget buckets are 11% Boating Fees/grants (strong sportsmen) and finally a whopping 1-3% from States General Funds. In other words sportsmen hunting & fishing dollars makes up the chassis, steering wheel, engine, drive train, 4 wheels....everything but the baggage compartment of the vehicle that drives ALL wildlife management in NV! As such we rightfully deserve the current majority position on the commission. Eco tourism adds virtually nothing to the \$40m annual wildlife funding vehicle.

2. The current and totally unbroken law requires that a majority of the members of the NV Wildlife Commission (5) are representative of hunters and fishermen by requiring that those 5 Commissioners are to be comprised of people who hunt and fish as determined by their possession of a valid hunting and fishing license. This is fair and provides representation for our self-imposed taxations.

Having 4-5 members of our wildlife commission needing nothing more than a US National Park Pass (can't make this stuff up) and not 10 years' experience as we heard mandated in other commission requirements, to meet the "sportsmen validity" will have the same effect as saying it would be ok if they had yearly membership to PETA, Human Society, or the Sierra club" which is exactly what some proponents of this bill would applauded....just wish they would be honest about it.

3. This law changes and disrupts the currently working conservation model and the successful historic dynamics of those who determine the expenditure of sportsmen funds, management and regulation of wildlife.

Legislatures in rural Nevada in particular should

be outraged as this bill is subjecting the Wildlife Commission to a Regional Representation Ploy. The Wildlife Commission should not be PACKED as FDR tried and was mercilessly ridiculed when he tried that with the SUPREME COURT makeup in 1937. This bill directs the majority of the say so to be made up by two population bases in the state, alienating where the majority of the wildlife actual exist, and whose population they effect personally and daily.


We need to keep it as it and its worth noting that the current commission make up was not only how Aldo Leopold the father of modern wildlife management expected...its similar to our founding fathers wisdom around Electoral College mandate!

We urge you to reject this bill as it is written, or at a minimum pull out section 9 and let's not try fix something that's not broken. From the NVFAC prospective this is a southern NV grab, and what's critical to you all today...that's exactly how the majority of your constituents will see it.

If you need further evidence of that last statement, look at the amount of your constituents that showed up in support of this bill, vs the dozens of wildlife professionals including x NDOW directors and commissioners current and past. As well as dozens of dedicated sportsmen and women that came out in stark opposition, all of whom took time off work to be here today! I would be glad to address any questions. Thank you


### "The Gun Is Civilization"

uman beings only have two ways to deal with one another: reason and force. If you want me to do something for you, you have a choice of either convincing me via argument, or force me to do your bidding under threat of force. Every human interaction falls into one of those two categories, without exception. Reason or force, that's it.

In a truly moral and civilized society, people exclusively interact through persuasion. Force has no place as a valid method of social interaction, and the only thing that removes force from the menu is the personal firearm, as paradoxical as it may sound to some.

When I carry a gun, you cannot deal with me by force. You have to use reason and try to persuade me, because I have a way to negate your threat or employment of force.

The gun is the only personal weapon that puts a 100-pound woman on equal footing with a 220-pound mugger, a 75-year old retiree on equal footing with a 19-year old gang banger, and a single guy on equal footing with a carload of drunk guys with baseball bats. The gun removes the disparity in physical strength, size, or numbers between a potential attacker and a defender.



There are plenty of people who consider the gun as the source of bad force equations. These are the people who think that we'd be more civilized if all guns were removed from society, because a firearm makes it easier for a [armed] mugger to do his job. That, of course, is only true if the mugger's potential victims are mostly disarmed either by choice or by legislative fiatith as no validity when most of a mugger's potential marks are armed.

People who argue for the banning of arms ask for automatic rule by the young, the strong, and the many, and that's the exact opposite of a civilized society. A mugger, even an armed one, can only make a successful living in a society where the state has granted him a force monopoly.

Then there's the argument that the gun makes confrontations lethal that otherwise would only result in injury. This argument is fallacious in several ways. Without guns involved, confrontations are won by the physically superior party inflicting overwhelming injury on the loser.

People who think that fists, bats, sticks, or stones don't constitute lethal force watch too much TV, where people take beatings and come out of it with a bloody lip at worst. The fact that the gun makes lethal force easier works solely in favor of the weaker defender, not the stronger attacker. If both are armed, the field is level.

The gun is the only weapon that's as lethal in the hands of an octogenarian as it is in the hands of a weight lifter. It simply wouldn't work as well as a force equalizer if it wasn't both lethal and easily employable.

When I carry a gun, I don't do so because I am looking for a fight, but because I'm looking to be left alone. The gun at my side means that I cannot be forced, only persuaded. I don't carry it because I'm afraid, but because it enables me to be unafraid. It doesn't limit the actions of those who would interact with me through reason, only the actions of those who would do so by force. It removes force from the equation... and that's why carrying a gun is a civilized act.
