We started 2017 by forming our NVFAC Foundation and by asking our various divisions to start offering more services for members and the shooters of this state. ## Realignment in a Free Market

The gun industry has always been susceptible to spikes and dips in sales based on market fluctuation, but the past few months have dealt a cold hard dose of reality to many gun retailers here in Nevada who had become accustomed to and relied heavily on a high demand for certain "self-protection" style firearms. A situation manifested not as a result of common market activity, but instead by a perception of many Americans based on their sense of safety and security.

The realization that the bubble created over the course of the past eight years may have begun to deflate started as a prediction back in January. It escalated to a rumor and finally hit home as a reality for me last week when the gun store down the street closed up shop and moved to Idaho because of slow sales over the past few months.

Americans tend to buy guns and ammo at a higher rate when they feel their safety is in jeopardy. Spikes in gun sales usually follow mass shootings, terrorist incidents, increases in crime and threats of confiscation by unethical politicians. Our (former) local gun store down the street was very successful in catering to that demand for the past several years and may have simply found themselves still standing when the music stopped.

The Obama administration's constant gun control threats caused a flood of sales as people looked to stockpile weapons ahead of anticipated new regulations. In fact, both of Obama's elections resulted in massive and unprecedented spikes in gun sales. It also created a boon for gun manufacturers whose stocks soared during Obama's reign. Many people have called Barrack Obama "the best gun salesman in history." (An irony lost on me quite frankly.)

As the past administration under Barrack Obama caused a bubble in the gun industry, the current administration under President Trump has pledged to roll back many gun laws and regulations. This pro-gun stance created a sense of security among Americans who for the most part no longer feel threatened by their federal government. As a result demand for the most popular self-defense weapons such as the

AR-15 referred to as "America's gun" by CNBC in their expose entitled, "The Rise of the AR-15" (a left-handed slap-in-the-face to lawful American gun owners), has declined.

In the run-up to the last election with Hillary Clinton, who vowed to confiscate guns during her campaign and who was the heavy favorite to win according to mainstream media sources, gun stores stocked up on "black rifles" and the associated ammo in anticipation of a huge upcoming demand. Sales continued to reach record highs after the election all the way through the holiday gift-buying season. However, come early January as Americans realized that for now, at least, the United States government was no longer interested in gun confiscation all that came crashing down.

Many gun stores had a glut of weapons and ammo that fewer and fewer people wanted to buy. Basic supply and demand tell you that while this may be a grave setback for retailers, it represents an opportunity for consumers. There are more great deals now than we've seen in years on certain types of firearms. The chance to take advantage of some of these deals has never been better.

Fortunately, this temporary slump in sales represents only a small segment of the marketplace. Hunting and sporting firearms sales are as brisk as ever. Gun manufacturers are producing more advanced products than ever before creating an unprecedented opportunity for new and experienced shooters alike.

It also provides an opportunity for organizations like the Nevada Firearms Coalition to provide free training through the hugely successful Annie Oakley training program for women. Our Annie Oakley shooting program is free gun safety training for women, conducted by women and is designed to teach firearms fundamentals to women who are interested in improving their shooting skills and learning gun safety.

Most mainstream gun manufacturers are ahead of the curve too. They're already introducing new models and styles targeting the sporting, hunting, and specialty markets. They do the

(Membership - Continued from Page 2) market research, and they understand the demands. A fluctuating market is nothing new in this industry. It can shift on a dime based on market pressures, economic slumps, and global events or as a result of threatening remarks by some uninformed politician.

It's just a matter of whether or not the industry as a whole is agile enough to circumvent economic catastrophe. What we see now is nothing more than the free market doing what it does best. A slight re-alignment of priorities based on demands from the consumer.

When Obama was president, I bought all the guns and ammo I needed. Now that Trump is president I'm buying all the guns and ammo that I want. That's a significant shift in attitude, and if that statement reflects the perspective of consumers in general, it represents a tremendous opportunity for savvy gun sellers.

As the firearms industry recognizes that many of the millions of Americans introduced

to shooting during the past eight years are now expanding into other areas of the shooting lifestyle such as hunting and sports shooting, it sets the pace for the entire industry to weather this re-alignment and come out smelling like a rose!

Local retailers are working through their glut of inventory by offering competitive pricing on some very high-quality products while stocking up on the products their customers are demanding. That represents the free market at its best. Unfortunately, as with any competitive industry, there will be winners and there will be losers, but when the dust clears, we'll all be better for it.

For now, it's a buyer's market and an excellent time for consumers to reap the benefits!

## Education & Training Division

Since the last newsletter, the NRA Personal Protection in the Home (PPITH), Personal Protection Outside The Home (PPOTH) and Basics of Pistol Shooting (BOPS) Instructor Led Training (ILT) courses have been offered, along with "Free Range Time", for Coalition members.

- For the 6th & 7th May PPITH course two Coalition members participated. There was one participant for the "Free Range Time" offered the morning of Sunday, May 7th.
- The NRA PPOTH course on May 27th & 28th had four Coalition members participate.
- The June 3 & 4 BOPS ILT course had four participants. No Coalition members took part in the "Free Range Time" offered the afternoon of June 4th.

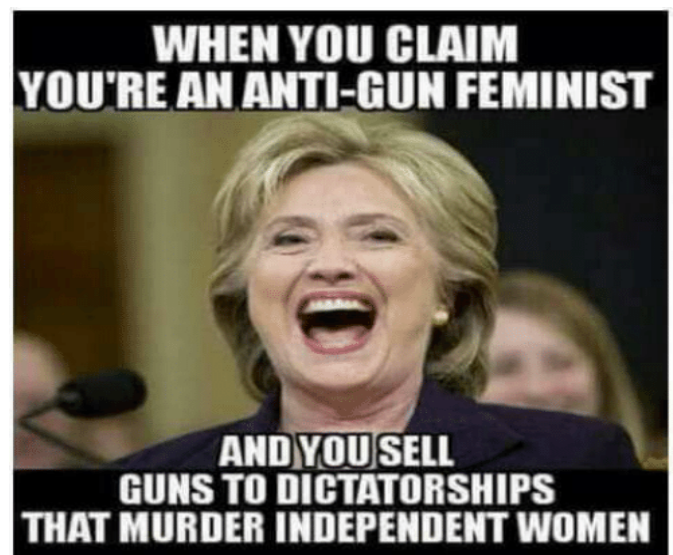
The reintroduction in April of Instructor Led Training for the NRA Basics of Pistol Shooting course, along with participation numbers for the programs offered, has made modifications to the Coalition's training program necessary.

One modification is the removal of the PPITH and PPOTH courses from the schedule. The PPITH and PPOTH courses are still available they've just been removed from the schedule. One factor in removing these courses from the schedule is they both have prerequisites. For the PPITH course a person must have completed the BOPS course. For the PPOTH course a person must have completed the PPITH course. Without people completing the prerequisite courses, there were not enough people to fill the required "break even" student count in the courses. Once we have a sufficient number of qualified students to take these courses, they will be put back on the schedule.

As for the "Free Range Time" it's just not feasible for the Coalition to pay for range time and have volunteer Range Safety Officers and Firearms Instructors show up to accommodate the event and no Coalition members attend. The "Free Range Time" will again be offered if there is sufficient demand from Coalition members.

Hopefully Coalition members will take note of the reasons for the changes made to the training program and understand that their participation is needed for the program to grow and prosper. # Annie Oakley Women's Shooting Program

On April 25, 2017 the NVFAC started a unique, out-of-the-box women's shooting program. Named the Annie Oakley Women's Shooting Program, it is offered every Tuesday night at the Clark County Shooting Complex (CCSC). Hosted by CCSC and sponsored/operated by the NVFAC this program is designed to offer firearms safety, secure storage, suicide prevention and basic handgun shooting to first-time women shooters. It consists of an hour safety and basic pistol craft lecture, followed by an hour on the shooting range.

The program, with the assistance of CCSC provides the use of .22 LR pistols without charge, and NVFAC provides targets and 125 rounds of .22 LR ammo. There are no fees required. Funded by the NVFAC Foundation (who raised funds through our Patriot's Day Banquet, and donation from several groups) the program is staffed by all women volunteers who fill the roles of instructor, range safety officers, coaches and greeters.

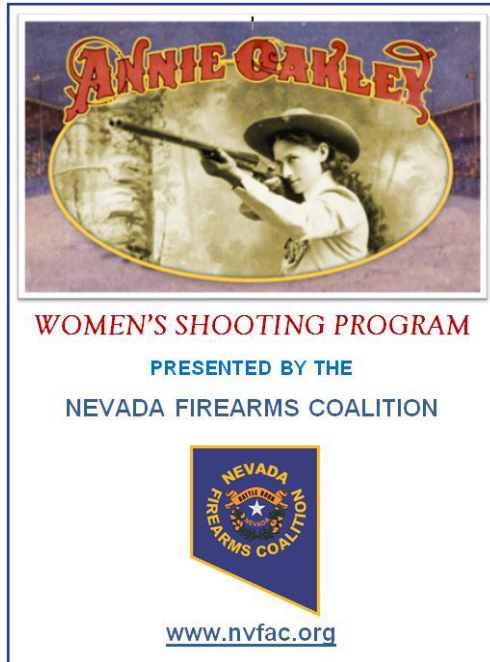
As of the end of June, the team consists of 41 women volunteers. It is managed by an overall coordinator, a volunteer coordinator and a coach coordinator. The response to this program has been overwhelming. On our first night, we were swamped and after adjusting our schedule were able to train 216 ladies the first night. Unfortunately, we had to turn away over an estimated 500 people. Offering the program on every Tuesday from April 25th to June 20th, our volunteers have trained 720 shooters, supervised 976 shooters by offering 20 classes and 26 range sessions. Over the last three weeks, we also offer classroom seminars such as gun cleaning, purchasing a pistol, etc. during the last hour.

We intend to continue this program indefinitely. So come down and join us women shooters every Tuesday night. Class is at 6:30 pm for new shooters. Range time is at 7:00 pm for returning shooters followed by a classroom seminar at 8:00 pm. New attendees shoot from

7 pm till 8 pm. Needless to say, we are very excited about this program and are appreciative of CCSC for their assistance, to all those who have donated to make this possible, and to our team of excellent volunteers who have stepped forward to provide a safe shooting experience and environment to the women shooters in Southern Nevada.

## Legislative Affairs Division Legislative Affairs Division

The 2017 Nevada Legislative session adjourned at midnight on 5 June 2017. To our pleasant surprise, when the dust had settled and all was said and done, we did much better in this session than we thought we would when it started. Thanks to a combination of good lobbying, good staff work, a good citizen outreach effort, and the combined efforts of concerned citizens and other Second Amendment advocacy groups such as the National Rifle Association's Institute for Legislative Action, several bad bills did not pass for one reason or another, and we were able to pass some positive bills.

We had the good fortune to hire a very effective lobbyist, Randi Thompson, who handled much of the interface with legislators, and who was the tip of our spear in defending your gun rights this year. We were also well served by Amplify Relations, who did their usual superb job of managing our PAC website and Facebook page, and provided other valuable support.

Much of our effort focused on 24 bills that we monitored and directly worked on that had a direct or indirect effect on your gun rights. Most of that work occurred behind the scenes, taking advantage of our contacts on both sides of the legislative aisle and with legislative staff.

### Some bad bills that failed include:

- AB 171, which allowed firearms to be confiscated for any crime or petty offense.
- SB 115, which prohibited firearms in and on the property of public libraries.
- SB 378, allowing firearms confiscation for any crime or petty offense.
- SB 351 & SB 378, allowing medical marijuana card holders to apply for a Concealed Firearm Permit.

### Some good bills that failed were:

- AB 97, allowing out-of-state CCWs for new residents to be honored for 120 days to allow time for a Nevada CFP to be processed.

- SJR 11, which amended NV constitution to protect hunting, fishing and trapping.

We even saw two good bills pass, which considering the 2017 legislative environment is worth cheering about:

- AB 118, allows persons in the military or honorably discharged from the military from 18 to 21 years old to obtain a concealed carry permit.
- AB 253, which improves reporting of mental health adjudications to the Nevada Criminal History Central Repository and their sharing with law enforcement to help reduce firearms possession by prohibited possessors.

The biggest wins for the session were the deaths of SB 254 and SB 387. SB 254 would have removed protection from civil lawsuits following a justifiable and legal self-defense shooting. SB 387 allowed temporary restraining orders and suspension of firearms rights in secret hearings and no notice to the subjects of the restraining order. This bill would have resulted in an infringement of due process the likes of which are not usually seen in free societies. We worked with the bill's sponsors and legislative leadership and were able to persuade them that these bills were not in the best interests of the Silver State.

The 2017 legislative session could have been MUCH worse for Nevada's gun owners. All things considered, we have much to be proud of, much to be thankful for, and many people to thank. The Second Amendment in Nevada did as well as it did this session because of concerned citizens up and down the Silver State, which includes organizations like the Nevada Firearms Coalition, the NRA-ILA and other like-minded groups working to protect your gun rights. Most of all, it includes the individual private citizens who answered the call to exercise their rights as free men and women to petition their representatives about matters important to them, which helped kill several bad bills, helped pass two positive

bills and made the session a success for all of us. That citizen involvement is reflected in our citizen outreach efforts with our Engage program (funded by a generous grant from the NRA), which resulted in:

- 18 alerts during the session to NVFAC members, PAC members and supporters for their action (contact state legislators or the Governor)
- 17,808 citizens' letters sent by members and concerned citizens to members of the Nevada legislature and the Governor.

We also had an excellent response to our

Second Amendment Day at the legislature in Carson City on May 1st, which had a good turnout of legislators and staff who were introduced or re-acquainted with firearms and gun safety.

All in all, it was a good session for us. Give yourselves a well-deserved pat on the back. You successfully defended freedom in Nevada this winter!

### Nevada Firearms Day at the Legislature Carson City, Nevada May 1, 2017

On Monday, May 1st, the Nevada Firearms Coalition put on a successful event in Carson City to help educate legislators on firearms safety and our BE AWARE program, as well as why it is so important to protect our 2nd amendment rights. The event was a great success, with over 120 people attending, 18 of whom were legislators.

Funded by a grant from the NRA, the event was held outside of the legislative building with a tent set up that housed an electronic laser simulation system for those who were interested to try target shooting.

The first people to stop by the tent were the lobbyists for law enforcement. All of them appreciated our being there to help raise awareness about how groups like the NRA and the Nevada Firearms Coalition provide gun safety training and suicide prevention programs. We had NSSF Project ChildSafe gun locks donated from the Washoe County Sheriff's office that we handed out, and they thought that was a great idea.

Several Republican legislators stopped by, including Senators Heidi Gansert, James Settlemeyer, Don Gustavson, and Becky Harris. Assembly Members included Ira Hansen, Robin Titus, Chris Edwards, Jim Marchant, John Ellison, Jim Wheeler, Lisa Krasner, Keith Pickard, and

Over 100 people tried their hand at shooting these simulated firearms. There were first taught how to hold the firearm, aim correctly, and most importantly how to be safe with a firearm. There were three different gun options that people could choose to "fire"; a hand gun, a shotgun and an AR-15. These firearms used lasers to fire at the targets and had CO2 cartridges to simulate the sound and feel of a real gun.

Reno Guns and Range provided the simulation as well as five instructors who mingled with guests and legislators and answered their questions and concerns. They talked about gun safety and how important it is to be educated on the safe use and storage of guns. They also talked to legislators about the impact of some of the bills at the legislature, especially those that are trying to take guns away from law-abiding citizens.

Food was also provided, which helped attract people to the event, but also kept them around, allowing more interaction with the instructors.

Many people remarked at what an informative as well as fun event this was. Several people had never shot a gun before, and said that shooting a gun wasn't as intimidating as they expected. Several expressed an interest in now going to

a range to target shoot. The more experienced shooters enjoyed the simulation and many requested information on CCW classes. Many said they appreciated the instructors talking about the safe use and storage of guns, and suicide prevention as well as how they now have a better respect for guns and gun owners, as they see what type of education it takes to be properly trained.

All of the instructors had different backgrounds, from military to retired law enforcement, and were able to talk with guests and legislators about the importance of gun safety and training, but also about the importance of the Second Amendment. One of the instructors was a woman, and it was very interesting to hear her speak with a female Assemblywoman who was not familiar with guns at all. She tried out the simulator and eventually hit the target spot on.

It was a very successful day that everyone enjoyed. We were pleased to hear many people tell us that the instruction was helpful, and that they learned something about guns and gun safety.
