I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage, or costs, including court costs and attorney's fees that they may incur due to mine or my minor child's participation in this activity. This agreement to indemnify includes loss, liability, damage, or costs, including court costs and attorney's fees, caused in whole or part by negligence of RELEASEES, to the fullest extent allowed by law.
- 3. I understand that loud noise, flying cases/shells and chemical particulates are some of the hazards associated the firing of cartridges/shells and these are a health risk. I understand protective measures such as hearing & eye protection, proper clothing, proper foot wear, and proper hygiene minimize these risks and I accept responsibility for minimizing these risks.
- 4. I understand that SAFETY is of paramount concern. I understand that I and or my minor child will follow all safety procedures and respond to safety officer instructions immediately. This includes abiding by the safety rules associated with this activity, and understanding that range officers may make physical contact to correct and prevent safety issues.
- 5. I certify that I have adequate insurance to cover any injury or damage I or my minor child may suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I or my minor child may have.
- 6. I as well as my minor child agree to abide by all rules and conditions set by RELEASEES and their agents, as well as all rules and conditions set for participation. I further acknowledge that failure to obey these rules and conditions would constitute contributory negligence on my part and at which time I or my minor child may be immediately removed from participation without refund of fees. I certify that I or my minor child is not a prohibited person under State or Federal law to possess any firearms or other devices.
- 7. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Nevada. Any portion of this document

deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions.
